Presiding Officer:

<u>Councilwoman Hudanich</u> explained that the 2014 budget provided for roads, but this year the amount is minimal because the Borough is doing an assessment.

Council President Covington mentioned the County is planning to repave Ocean Drive in 2016.

Martha Wright, 632 7th Street, stated she has looked at expenses paid to Lomax and questioned if Professional Services Contracts are reviewed yearly to see how much is being spent by the Borough. She encouraged Council to look at the expenditures more closely.

Reports and Recommendations by Mayor and Officials: Reports of Officials:

Scott Wahl, Business Administrator updated Council on the Peermont Substation project. He said a meeting was held on Friday, March 23rd in Borough Hall to discuss the ongoing project regarding the construction of the new Peermont Substation in Avalon between 60th and 61st Streets. He said the Borough received a timeline of construction of the substation to meet the current and future energy needs of the Seven Mile Island, and to reduce the number and duration of power outages in the Borough during storm events and other emergencies. He reported construction will continue through Thursday, May 21st when construction will cease, a safety/security fence will be installed, and the site will have no activity through the entire summer including Labor Day weekend; after Labor Day weekend the construction begins again with the current substation being de-energized and removed, and the new substation constructed and energized to be in service before Memorial Day weekend, 2016. 


