#### **ORDINANCE NO. 663-2012**

AN ORDINANCE AMENDING CHAPTER 27 (ZONING) OF THE CODE OF REVISED GENERAL ORDINANCES, 2000 REGARDING RENTAL LICENSE TERM TO CHANGE THE DEFINITION OF "HOTEL OR MOTEL" TO CONFORM TO THE DEFINITION OF "HOTEL" IN N.J.S.A. 55:13A-3(j)

WHEREAS, Chapter 27, Section 27-3, entitled "Language Interpretations and Definitions" of the Code of Revised General Ordinances of the Borough of Avalon includes subsection (C), entitled "Definitions" which sets forth the meanings or certain words and phrases as they are used in Chapter 27; and

WHEREAS, Borough Council desires to amend the definition of "Hotel or Motel" contained in Chapter 27, Section 27-3 (C) to conform to the definition of Hotel set forth in N.J.S.A. 55:13A-3(j).

**BE IT ORDAINED** by the Borough Council, in the Borough of Avalon, County of Cape May and State of New Jersey, as follows:

**SECTION 1:** The definition of "Hotel and Motel" Chapter 27, Section 27-3(C), is amended to provide as follows:

Hotel or Motel. Any building, including but not limited to any related structure, accessory building, and land appurtenant thereto, and any part thereof, which contains 10 or more units of dwelling space or has sleeping facilities for 25 or more persons and is kept, used, maintained, advertised as, or held out to be, a place where sleeping or dwelling accommodations are available to transient or permanent guests.

This definition shall also mean and include any hotel, motor hotel, motel, or established guesthouse, which is commonly regarded as a hotel, motor hotel, motel, or established guesthouse, as the case may be, in the community in which it is located; provided, that this definition shall not be construed to include any building or structure defined as a multiple dwelling in this act, registered as a multiple dwelling with the Commissioner of Community Affairs as hereinafter provided, and occupied or intended to be occupied as such nor shall this definition be construed to include a rooming house or a boarding house as defined in the "Rooming and Boarding House Act of 1979," P.L. 1979, c. 496 (C. 55:13B-1 et al.) or, except as otherwise set forth in P.L. 1987, c. 270 (C. 55:13A-7.5, 55:13A-7.6, 55:13A-12.1, 55:13A-13.2), any retreat lodging facility, as defined in this section.

SECTION 2: REPEALER: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only. All other definitions set forth in Ordinance 27-3(C) shall remain unchanged by this Amendment.

**SECTION 3: SEVERABILITY:** If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

**SECTION 4: EFFECTIVE DATE:** This Ordinance shall take effect immediately upon final adoption and publication and in the manner prescribed by law.
