The occurrence of this meeting will be duly noted and placed on the agenda for the next regularly scheduled meeting to be held on Wednesday, October 25<sup>th</sup>, 2017 at 4:00pm in this room.

The format of this meeting will be to approve a resolution that authorizes the holding of this meeting without adequate notice; to approve a resolution that will enable Council to go into closed session to consider the settlement agreement; and to come out of closed session with potential action taken by Council.

It is important to note that the Avalon Planning and Zoning Board will also hold an emergency meeting at 3:00pm today. Shall a settlement agreement be reached, all parties—Avalon Anchorage Marina, the Avalon Planning and Zoning Board, and the Borough of Avalon-must hold this agreement in strict confidence as it must be considered and approved by Superior Court Judge Julio Mendez.
