Reports and Recommendations by Mayor and Officials:

Reports of Officials:

Scott Wahl gave a summary of the following report:

Townsend's Inlet Bridge: The issue with the Townsend's Inlet Bridge was discovered during an underwater inspection being performed to gather information for a planned substructure repair program this upcoming off season. Greenman-Pedersen, Inc. is the design engineer for this repair program and they are leading the design of the emergency repairs to Pier 6 (numbered from the south) of the Townsend's Inlet Bridge. The County has engaged South State, Inc. to perform the construction and Maser Consulting PA to oversee the construction operations.

The proposed emergency repair program involves installing 3 150-foot long pipe piles on both the bay and ocean ends of Pier 6 and attaching the piles to the existing pier cap. Due to conflict at the bridge with the new piles, South State has removed the safety walk and bridge railing over Pier 6. During the last three days South State has been moving riprap stones on the inlet bottom to permit the installation of the new piles. The piles are being delivered in 50-foot lengths to the loading dock at Avalon Point and are welded together for the initial setting of an 100-foot piece. The final 50-foot section of pile is welded once the pile has been partially driven into the inlet bottom and is in a secured position. All piles are expected to be delivered by supplier before the end of this week. A marine-grade coating has been applied to the piles.

Assuming the inlet bottom in the area of the new piles gets cleared of the riprap stone tomorrow (April 27th), it is anticipated that the first pile will be installed early next week (week of May 1st). South State will be working extended hours as needed to install the piles Monday through Saturday each week, as long as weather conditions permit the work to occur.

Chain-link fence has been placed around the areas where the bridge railing and walkway have been removed. Pedestrians, fishermen and bicyclists can cross the bridge when active work is not ongoing, however bicyclists need to walk their bikes through the work zone. During working hours, the Contractor will shut down the passage of folks through the work zone, particularly during pile driving and other related at-risk activities.

Due to conditions in the inlet, the barges are moved out of the area when not in use. The construction activities and the barge placement is not expected to impact marine traffic. It is our goal to have the bridge re-open to vehicular traffic by Memorial Day weekend.

Stone Harbor 96th Street Bridge: Cape May County Engineer Dale Foster has announced that the 96th Street Bridge Priority Structural Repairs construction project is underway. The bridge is a county owned and operated bridge and will be under construction by Agate Construction Company, Inc. Before Memorial Day weekend, the bridge will be closed to all traffic overnight between the hours of 10:00pm and 5:00am from Sunday night to Thursday night.

Between Memorial Day weekend and June 9th the bridge closures are the same time but are limited to Monday nights through Thursday nights. The contractor is also permitted to close a lane at any time from Sunday, 9:00pm until Friday, 5:00am. The alternating of traffic in the remaining open lane will be controlled by traffic signals. No lane closures or complete closures are permitted after Fridays at 5:00am, all day Saturdays, and until 9:00pm on Sundays. The project will be completed by June 9th; if it is not, work will be deferred until the fall. All lane and complete closures are weather-dependent.

When the repair work is finished on the southwest movable girder, the bridge will once again be able to carry legal loads and the current weight restriction on the bridge will be removed.

Beach Fill Project: The sea conditions right now are 5-7ft at both the Cape May & Townsend Inlets. The forecast is for the seas to start calm down but it will take until Thursday afternoon before the conditions will allow the dredge to get into the Townsend inlet and setup. My guess is that the Texas will start up tomorrow night.

Special Events: The Avalon Garden Club will host an Arbor Day celebration on Friday, April 28th at 10:30am. The public is invited to attend the event to be held at the 66th-67th Street traffic island along Dune Drive. A honey locust tree will be planted on the island. There will be comments from Garden Club members and from Dr. Brian Reynolds from the Avalon Environmental Commission.

Avalon Police Chief William McCormick announced that on Saturday, April 29 from 10 a.m. to 2 p.m. the Avalon Police Department and the Drug Enforcement Administration (DEA) will give the public its 12th opportunity in seven years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to Avalon Police Department at 3000 Dune Drive, Avalon, NJ. (The DEA cannot accept liquids or needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.
