Council President McDermott read the Open Public Meetings Act Announcement.

Notice of this Council Meeting was included the annual Schedule of Meetings dated July 12, 2023. It was given to the news media and posted on the Official Bulletin Board as required by law.

Council President McDermott read the following statement:

"For the convenience of the public, the Borough is offering the option of public comment via remote access as described herein. Public who participates remotely will be muted during the Council Meeting except at the public comment portion of the meeting. Any person attempting to disrupt the remote broadcast of a meeting may be denied access at the discretion of the person administering the meeting. Public is reminded of a five-minute limit per comment. Borough Council Meetings are held in person with no capacity limits on attendance at a meeting. 
<u>Discussion regarding bids received for the project known as Contract M-136, 78th Street Water and 29th Street Sewer Improvements.</u>


<u>Thomas Thornton</u> reported six bids were received on January 10, 2024 for this project, which includes the replacement of a 2-inch galvanized water main on 78th Street between Ocean Drive and Sunset Drive, and the replacement of a half-block of sewer main on 29th Street between Ocean Drive and Dune Drive. The bids received were very competitive, with the low bid being within one percent of the Engineer's estimate. That bid was submitted by Mathis Construction Company, Inc., and it is recommended that the Borough award this contract to the lowest bidder.

Council agreed to proceed with Resolutions to be considered at today's Council Meeting.

New Jersey Water Allocation Permit

A Water Allocation Permit is required for the diversion of ground and/or surface water in excess of 200,000* gallons per day for a period of more than 30 days in a 365 consecutive day period, for purposes other than agriculture, aquaculture or horticulture. This includes water diversions for public water supply, industrial processing and cooling, irrigation, sand and gravel operations, remediation, power generation, and other uses. For these use types diversion limits are set within a Water Allocation Permit, Water Use Registration, or Permit-by-Rule. Avalon has a Water Allocation Permit for 502,000,000 gallons of water annually.

How Is Water Provided to Avalon?



Avalon has five water wells with the goal of running four peak season (May 15-October 15), and one as a backup:

- 12th Street and Ocean Drive
- 13th Street and Dune Drive
- 30th Street, near the Public Safety Complex
- 38th Street and Dune Drive
- 67th Street and Dune Drive

In 2023, all five wells were running 24/7 at times during peak season. The 30th Street well needs mechanical service

Note: To install a fifth water well or a third water tower would involve many years of expensive permitting and millions of dollars in construction costs.

Excessive Water Use: Irrigation




Our community has more larger homes and a proliferation of swimming pools.


However, it is proven that irrigation is by far the largest water use in the Borough, not only on properties but by the Borough itself.

How can we make that conclusion?

Exhibit: 13th Street Water Tower Graph



The 13th Street water tower has a 250,000 gallon tank. At midnight each day, the tank has 25-30 feet of water. By sunrise, the tank has 10 feet of water, or less due to daily irrigation, with all wells working at full capacity.



2012-Water Irrigation Ordinance

Avalon amended Chapter 14, to include two zones for every other day watering, with no watering allowed on Monday. Times were restricted to Midnight-9:00am. Smart technology controllers and rain sensors were required for all new installs of irrigation.

We see irrigation running during daylight hours, spraying on curbs and sidewalks, daily irrigation of certain properties, irrigation during rainstorms, and other circumstances



Suggestion for Plan Moving Forward

- Education campaign to inform property owners about Borough ordinance, expectations to comply.
- Utilize both Spring and Fall, 2024 newsletters to educate, along with a social media campaign
- Engage all landscapers who do work in our community with the Borough ordinance with recommendations to check rain sensors and timers to comply with the ordinance
- Have a flier that can be distributed to property owners when it is noticed compliance is not followed
- Investigate Borough irrigation systems for compliance and working rain sensors for ordinance compliance. Funds are placed in the Mayor's budget for consideration to upgrade irrigation, where necessary, to comply with the existing ordinance.



<u>Ken Koches</u> thanked Scott Wahl and the Department of Public Works for conducting this test in August to prove irrigation as the number one aggravating cause of water usage, further noting the strain on all other wells was lessened when the Borough reduced its irrigation schedule. In summation, this was a small experiment that succeeded, and more success is anticipated if property owners comply.

Scott Wahl stressed the importance of educating property owners about the irrigation Ordinance.

After brief discussion, Council expressed appreciation for the presentation and supported this initiative.

<u>Councilwoman Juzaitis</u> suggested evaluating all irrigation of the planted islands on Dune Drive to avoid runoff into the street.

<u>William McCormick</u> responded that evaluation is an ongoing process, and some corrective action has been taken to date.

<u>Discussion regarding Resolution releasing all previously imposed Deed Restrictions pertaining to conditions such as minimum lot size, minimum square footage, and two-story height restrictions.</u>

Nicole Curio explained any time a municipality releases deed restrictions or waives any other restrictions on a property that has been deeded over, the governing body is required to adopt a Resolution to that affect, as well as hold a public hearing in advance of the Resolution adoption. In 2020, the Borough of Avalon held a global public hearing releasing all restrictions and adopting a new restriction release policy; however, the requirement for the application process and release of deed restrictions individually by Resolution was still required. Council is now being asked to amend the process further and take formal action upon a global Resolution after another global hearing addressing all properties sold by the Borough prior to 1979. The Resolution would release all existing site improvement deed restrictions previously imposed on those properties when sold, including minimum lot size requirement, first floor square footage minimum, and a two-story height restriction. This Resolution sets a date and time for the final global hearing whereby after that, Council may pass a final Resolution on the matter in addition to adopting a new Ordinance amending the current process. The new process eliminates much of the administrative process, and allows the global Resolution to serve as Council's approval that these restrictions are officially released. The Borough Clerk and Solicitor will continue to review every application for consistency and compliance with the new policy.

Council agreed to proceed with a Resolution and Ordinance to be considered at today's Council Meeting.

Public Comments:

Martha Wright, 632 7th Street, spoke about the egregious decimation of the maritime forest within the high dunes located on or near 5609 Dune Drive, and expressed the opinion that the Borough, as well as the Borough's environmental consultant, The Lomax Consulting Group, are culpable for the disgrace to the community, the Borough, and the state of New Jersey as a whole. She stressed that the Dune Vegetation Management Plan was not appropriately followed, and further voiced the opinion that The Lomax Consulting Group did not sufficiently supervise the project near this property, which allowed the clear-cutting that occurred. She opined that no amount of remediation will ever restore the area to its original condition. She requested that Council advise if the homeowner will be fined for this outrageous action, if the Lomax Consulting Group will have payment withheld for this oversight, who the Borough assigned oversight of this project, how a Certificate of Occupancy was granted with over 8,000 square feet of protected land cleared of vegetation unlawfully.

Council President McDermott stated Borough Council is in full support of the actions being taken by the New Jersey Department of Environmental Protection (DEP) in an effort to remediate the wrong-doing within the maritime forest at 5609 Dune Drive. That property received approval of the final as-built survey from the Avalon Environmental Commission, and Avalon Planning/Zoning Board, which pledged no disturbance of the dunes. The Borough is reviewing the actions that can be taken while supporting the DEP to restore the natural vegetation that has been destroyed there. He explained the Borough has found no wrong-doing by any Borough official or contracted firm at this point in the investigation, as these violations were committed after all approvals were issued. The DEP has issued violations and mandated corrective action, and at this time, this matter is solely within the DEP's jurisdiction.
