Councilwoman Hudanich concluded the presentation by stating this is a very fiscally sound budget that will maintain the Borough's AAA rating, and announced she has been making the budget presentation along with Council Vice President Covington as a financial team since 1991. She made note that Council Vice President Covington has been an integral part of the financial component of the Borough with his innovative thought process and his background in technology. She stated it has been a joy, a pleasure, and a wonderful experience working together that she will never forget, and was saddened that this would be the last presentation made by Council Vice President Covington in advance of his retirement from Council.

Council Vice President Covington mentioned the Borough has come a long way since the 1991 budget.

Councilwoman Hudanich agreed and listed a few "stellar moments" made during their journey as a financial team, such as the creative structure of the water and sewer rates and extracting the infrastructure charge from the water usage.

Council Vice President Covington expressed happiness at leaving the Borough of Avalon financially sound as he closes his career as a Council Member this year, and indicated this budget is one of the best that has been put together. Unlike some municipalities, the goal of the Borough of Avalon is to be debt free and he expressed his faith that the goal will be achieved.

Councilwoman Hudanich explained the Borough has been diligent in paying down payments of 15% or 20% when bonding large projects, and noted the money brought in by the revenue stream has been spent wisely, effectively and efficiently, however most importantly, the Borough is fortunate to have a strong Administrative Team that is proactive in applying for grants to get the State and Federal governments involved in projects throughout the Borough. As an example, when the CDF Road was built, the team worked diligently to keep what a large amount of Borough money was used to construct. Between the Administration and the foresight of the Mayor and Council, it has been a pleasure to work on such an arduous task as the budget.

Councilwoman Juzaitis commended the Financial Committee as well as the Administrative team for the hard work that went into compiling the budget and thanked them for all of their efforts.

Council President Deever noted it is often overlooked how hard the Financial team of Council Vice President Covington and Councilwoman Hudanich work to maintain the Borough's fiscal responsibility to the members of the public, and expressed appreciation for their diligence.

Councilman McCorristin commended the outstanding work done and thanked all involved in compiling the budget.

Reports of Officials:

Scott Wahl read the following report:

Street Grant: Since Council's last meeting, Avalon received a letter from the Commissioner of the Department of Transportation. The letter acknowledged that the Borough has received a state grant totaling \$150,000 for the reconstruction of one block of 68th Street between Dune and Ocean drives. There were 681 applications for grant funding this year; grants are supported by the State's gasoline tax. Since the late 90s, Avalon has secured \$2.7 million in grant funding for new streets in this program.

<u>Townsend's Inlet Bridge:</u> Courtesy of vast media coverage on this matter, most of us are aware that on Monday, April 8th, 46 days before Memorial Day weekend, the County issued a notice stating that the completion of the Townsend's Inlet Bridge is anticipated to be "late summer". It is our expectation that the bridge will remain closed through Labor Day weekend. Avalon and Sea Isle City are expected to receive an update within 30 days of a firmer completion schedule. There has been no communication to Avalon if further work that requires more closures will be needed in the fall.

Scott Wahl continued: Surfside Park: Another progress meeting will be held tomorrow morning in this room. There have been no substantive delays with this project and no safety concerns. Anyone who attends the Community Connections event this Saturday at AHLOA will see significant progress at the park site with playground equipment installed, structures being worked on. The landscaping and open field will be the last components of this project.

<u>Dredging Project</u>: Earlier this year Council authorized a dredging contract to Trident Marine to conduct a small mechanical dredging project to clear the navigation channel on the west side of 21st Street. That project should conclude by the weekend as the contractor has been on the job for several days. There have been no substantive issues relating to this project.

<u>Backpassing Project</u>: We have been largely blessed with favorable weather for the sand back passing project being conducted by the Avalon Department of Public Works. As of Tuesday, April 9th, the staff have moved a total of 19,438 cubic yards of sand during the project. The actual transporting of sand began one week ago today. At the beginning stages of any backpassing project, there is some sand loss until the new sand sticks to the beach and stays in place. We have seen less attrition to date due to relatively calm winds and weather conditions.

<u>Water Flushing Program</u>: Middlesex Water Company has announced that the semiannual water main flushing program will begin on Monday, April 22nd. Residents who see temporary discolored water are simply asked to run it for a few minutes until it clears up; residents may also experience a temporary drop in water pressure that again should clear up within several minutes.

Public Comments:

Jim Lutz, 2539 Ocean Drive: expressed his disappointment with the turnout regarding the 2019 Municipal Budget. As a result, he spoke in support of live streaming Council meetings, where very valuable information would be disseminated and furthermore Avalon residents could become more involved in the community. He voiced his concerns regarding the construction of Townsend's Inlet Bridge by urging Council to keep the pressure on the County as this is vital to all of the businesses in the community.






