RESOLUTION NO. 79-2019

**SUBJECT:** A RESOLUTION AUTHORIZING THE SALE OF ABANDONED AND UNCLAIMED  
PROPERTY ON SATURDAY, MAY 11, 2019

**WHEREAS,** the Borough of Avalon is in possession of certain abandoned and unclaimed property which is no longer needed for any public purpose; and

**WHEREAS,** the Borough reserves the right to withdrawal any item from the auction when legal ownership is legitimately questioned; and

**WHEREAS,** it is appropriate to dispose of such surplus municipal property as provided by law.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Avalon, County of Cape May, State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.
2. The Borough Clerk is hereby authorized and directed to advertise a public sale of said surplus municipal personal property to be held on May 11, 2019, inspection of items commencing at 11:00 a.m., and auction commencing at 12:00 p.m., prevailing time. Said sale is to be held at the Avalon Public Works Facility, 1401 Dune Drive, Avalon, New Jersey.
3. The abandoned and unclaimed property is identified in Schedule "A" attached hereto.
  - a. The sale shall be subject to the following terms:
    - Property is sold "AS IS" without any warranty, expressed or implied.
    - Upon closing of bids, the highest bidder shall submit the full bid price in cash, certified check, cashier's check, or any combination thereof.
    - Bidders shall take delivery of personal property at the time of said sale.
    - The Borough of Avalon reserves the right to reject any and all bids.
    - Said sale shall be in the manner of a public auction.
4. The Borough Clerk shall cause a copy of this Resolution to be advertised in the Press of Atlantic City in the edition of April 15, 2019 and a copy of this Resolution shall be posted on the official bulletin board at the Avalon Borough Hall and a copy shall be sent to any party who has heretofore expressed any interest in purchasing any one or more of the items of abandoned/unclaimed property described in Schedule "A" is attached hereto.
