Public comments regarding Resolutions:

Martha Wright, 632 7th Street referenced the first Resolution on the agenda authorizing a Place-to-Place transfer on behalf of Z21 Corp, and mentioned knowledge of the item being discussed at Work Sessions held by Council on December 18, 2019 and January 8, 2020. She noted her inability to attend the Council Meeting held January 8, 2020 and inquired as to what was being authorized by Council in the Resolution being considered this evening.

<u>Council President Hudanich</u> stated the Resolution being considered this evening grants the Place-to-Place Transfer to expand the licensed premises to include a newly constructed outdoor patio. The application also requested release or relief of a Special Condition restricting the sale of alcohol to outdoor dining patrons past 12:00 midnight, and that time is not being changed.

Councilman McCorristin clarified the wording of the Special Condition has changed so that the bar cannot serve people past 12 midnight, however if an outdoor patron has an alcoholic beverage in their possession that was served prior to midnight, they are permitted to take their time consuming their beverage, even if the consumption lasts past 12 midnight.

<u>Council President Hudanich</u> explained there was a need for more explicit verbiage pertaining to that condition, which has been clarified. Alcoholic beverage service will still cease at midnight.

Reports and Recommendations by Mayor and Officials: Reports of Officials:

Scott Wahl read the following report:

<u>39th Street Pumping Station:</u> The CMCMUA is in the process of a major project to rehabilitate the interior of our Pumping Stations. To accomplish this, the pumping stations themselves must be setup with bypass pumping outside of the station.

The work at the pump station located at 39th street is scheduled to being the first week in February and last through the end of April, with the bypass operation being set up from 2/4/20 through 3/18/20. The bypass set up will not interrupt any service within Avalon. It will limit access to the tennis court parking lot from the Ocean Drive Side and limit walking paths in front of the station.

Atlantic County JIF: The JIF announced that a substantial dividend is being released to all of the members of the Fund due to the performance of its members. This year, Avalon is awarded a \$71,797 dividend that will be applied as a credit to the second quarter assessment. Also, I serve on the JIF's Safety Committee and the Committee decided to elevate the criteria for members to earn various safety incentive bonuses. I voted in favor of that measure. We intend to come before Council next month to ask for a formal resolution that would authorize the Borough to participate in the new Safety Incentive Program which was discussed in detail at our municipal safety meeting last week.

<u>U of Pennsylvania Resiliency Conference:</u> Last Thursday I attended the resiliency conference held at the University of Pennsylvania that was attended by about 75 invited guests. Avalon had the privilege of hosting the first discussion with Dave Rosenblatt from NJDEP who is now the new Assistant Commissioner of Resiliency and is required by executive order to present the first resiliency document to the Governor by September 20th. A few takeaways from the conference for Avalon include 1) The State will be looking for communities with a dedicated source of funding for resiliency projects when it identifies pilot projects and a funding source; 2) There are additional sources of grant funding that I identified at the conference for these projects; 3) Other states have granted the ability to use dredge material for things like core of dunes and living shorelines, even deep water disposal and New Jersey appears to be going in that direction as well. I have a few ideas that will advance Avalon's efforts for which I would like to bring to Council sometime in the first quarter for consideration.

Louisiana, Ohio and even a project in North Jersey are now using dredge spoils innovatively and we have been restricted in New Jersey of how we can use this material: it must be tested, clean, consistency, sand ratio, etc. Discussions have taken place with representatives of Louisiana and Ohio who have copious opportunities to use the same type of material that we do. Steve Morey from Mott MacDonald agrees the Borough should take a look at the economic benefit of beach restoration. Why can't this material be used for the core of dunes, which will create a firm structure and allow more sand to be available for beach nourishment. Another thing is with this living shore line, and the Wetland's Rehabilitation, there has to be some science out there that looks at this to say this material could be used for these projects. With the encouragement and support of FEMA, Council and the Mayor, it is being requested to initiate more conversations with Mr. Rosenblatt in his new role to say the Borough is committed to dredging materials and are advocating better use of those spoils.

<u>Council President Hudanich</u> spoke in favor of better utilizing dredging spoils and noted her experience in watching a presentation entitled "There's Soil in the Spoils" which detailed a Union City shopping mall on dredging spoils. She advocated for viewing such use through a financial lens for smarter management.
