# Reports of Officials:

Scott Wahl read the following report:

<u>Ingram's Thorofare Bridge:</u> The second of two consecutive overnight closures of the bridge is anticipated this evening. It was brought to my attention today that the bridge was not open as advertised by 5:00 a.m. this morning which caused confusion for motorists. At 2:30 p.m. today I brought that to the attention of Cape May County Engineer Robert Church who assures me the Cape May County contractor was going to be corrected before the start of this Council meeting.

<u>AHLOA</u>: The Borough wishes to thank the Avalon Home and Land Owners Association in advance for the opportunity to present an overview of the 2020 Avalon Municipal Budget at its meeting Saturday morning at the Avalon Senior Center. Councilman McCorristin will lead the discussion.

<u>Avalon Recreation:</u> Avalon Recreation Department pee-wee basketball ended Friday February 28<sup>th</sup> with our annual end of the season banquet. We had approximately 192 people in attendance. It was a very successful season. We offer two age groups, Pre-K and K, and 1<sup>st</sup> and 2<sup>nd</sup> grade. We practice every Friday night during the season and games on Saturdays. Parent volunteer coaches conduct the practices and monitor the games. Kids are learning how to dribble, pass, shoot, proper footwork, and having fun while doing it. The Pre-K and K division had 52 participants, and the 1<sup>st</sup> and 2<sup>nd</sup> grade division had 57 participants. Participants come from all over the county to take part in this program. The season runs from January through February every year.

<u>Council President Hudanich</u> reported the population of preschoolers has boomed in Cape May County to the extent that Lower and Middle Township Schools are expected to expand their Pre-K classrooms. She noted this is good news for the County demographics, as the student population has dwindled over the last five years. She expressed excitement about these expanding age groups, and congratulated all of the basketball teams on their success.

<u>Councilman Deever</u> added the pee-wee basketball season was well received this year and was well-run by the girls' basketball team in Middle Township.

<u>Councilwoman Juzaitis</u> spoke highly of the program and expressed excitement at the attendance figures and those that came out to support the players.
