## Reports of Officials:

## Scott Wahl read the following report:

A brief update on the Covid-19 situation, particularly as they relate to new executive orders issued today by Governor Phil Murphy.

First, the total number of cases have increased statewide to 47,437, and the total number of those deceased has increased to 1,504.

Governor Phil Murphy has issued two new executive orders that impact Avalon and other municipalities.

First, the date of the primary election in New Jersey has moved. It will not be held on June 2<sup>nd</sup>, it will be held on July 7<sup>th</sup> instead. It is the intention of the Borough to hold this at our typical polling place, Avalon Community Hall.

Second, there is a new executive order regulating construction. I was on a County conference call at 2:30pm today. It appears that any construction for the public good can continue. This appears to include all municipal projects, including but not limited to the reconstruction of the jetty, street projects, the County project on the Ingram's Thorofare Bridge.

It appears that construction on single family homes remains permissible as long as the number of workers on the site remains at five or under. If there are more people on the site, that is a violation of the executive order. This is the interpretation of the County and we expect further guidance. I will make sure this order is on the municipal website and passed on to our enforcement agencies including Avalon Police and Code Enforcement.
