Reports of Officials:

Scott Wahl read the following report:

Ocean City Court: Our neighbors in Ocean City experienced an emergency technology issue on Tuesday relating to their court operations. At my request, Avalon's shared court responded and was able to provide all of the services requested by Ocean City to have their court. I would like to complement our new Court Administrator Wendy Torroni and Deputy Administrator Liz Giratoudis for stepping in and helping with this emergent condition. Their efforts have been recognized by our vicinage.

<u>Dune Drive Beautification Plan:</u> I have been working with Mayor Pagliughi before and through the holiday period on a replanting/beautification of Dune Drive in advance of the season. We will be asking Council to consider this endeavor for this spring to vastly improve the aesthetics of our traffic islands and other Dune Drive greenery. The plan will include replacement plantings for dead trees that have been removed with a plan to fix any irrigation issues shall they be discovered during this effort. The substantial completion date for this will be before Memorial Day weekend.

Emergency Alerts: During the holiday period, I was involved in advanced training regarding our emergency alert system. As previously reported to Council we will be expanding the scope of potential use of our Code Red alert system provided by OnSolve. This will allow us, during timely emergent conditions, to issue quicker phone alerts and text alerts, when necessary for an imminent threat like a tornado or other disaster. When appropriate, we will be able to issue alerts in special zones through our community when an issue is indigent only on a specific portion of Avalon.

<u>Covid-19:</u> The pandemic certainly remains a focus of our individual breakout meetings and Safety Committee meetings for which Councilwoman Juzaitis not only attends, but is an active participant with our group. To date, no municipal executive orders have been rescinded. We have a working group that will present for Council's consideration at our next meeting amendments to our outdoor dining policies as it was warmly received by the public and deficiencies shall be corrected with the amended Temporary Emergency Response Plan. We have on the front page of the website the appropriate link for individuals to sign up for the vaccine. Avalon Community Hall continues to be used by the County as a vaccination location initially for those in the medical field, and next for first responders.

The latest statistics: As of this morning, Cape May County has experienced 4,992 cases during the pandemic, and 150 deaths. Our seven-day average is 58 cases per day. There have been 1,681 vaccinations at Avalon Community Hall of medical professionals and first responders. Police/fire was moved from 1B to 1A, and a move to transition into 1B is made by the State.

Councilwoman Hudanich asked if the vaccinations are by appointment only.

Scott Wahl replied yes.

<u>Councilwoman Juzaitis</u> recognized Avalon and their efforts to support dissemination of the COVID-19 vaccine, while noting Cape May County is receiving a limited quantity of vaccinations and commending all involved for their hard work.

<u>Councilwoman Hudanich</u> complimented Councilwoman Juzaitis for not only being an instructor at the Cape May County Technical School, but also having a Master's Degree in Infectious Disease. Practical Nurse students and staff members of Cape May County Technical School have vaccinated approximately 1,000 people at Shore Memorial Hospital. She complimented everyone who is working together in these unprecedented times.

<u>Councilman Wierman</u> thanked the Avalon Police Department for their help with crowd control at the highly attended Planning/Zoning Board Meeting on January 12, 2021.
