Reports and Recommendations by Mayor and Officials: Reports of Officials:

Scott Wahl expressed his gratitude for the timely adoption of Ordinance 813-2020 and personally thanked Councilman Wierman for participating with this committee and exhibiting dedication to 5G technology. As reported in previous Council meetings, Avalon's intent behind adopting said Ordinance was to stay ahead of State Legislation, which could affect a municipality's control over certain regulations concerning 5G. Two days ago, the State committee approved the State's plan for wireless implementation. He went on to read an excerpt from minutes recently approved by the Cape May County Open Space Board concerning Avalon's Bay Park Marina, as follows: "Mr. Craig recommended approving this item in the amount requested one million one hundred ten five hundred seventy-six dollars and seventy-one cents (\$1,110,576.71) with the condition the Borough actively engages in the process of adding public art to the site over the next 12 months. All members are in favor." He expressed appreciation on behalf of the Borough of Avalon for the support of the Open Space Progam.

Scott Wahl read the following report:

<u>NJTT Grant:</u> As Council is aware, our partners at the 7 Mile Business Community Association and the Avalon Chamber of Commerce, through the efforts directed by Jacqueline Ewing, apply annually for a state travel and tourism grant. This grant largely supports the Thanksgiving weekend activities in Avalon, along with other tourism initiatives. Ms. Ewing applied for the grant earlier this year and on November 25th received notice that the State will provide \$17,750 in funding to the 7MBCA for support of our activities. The Borough certainly continues to be deeply appreciative of these efforts and appreciates the State looking favorably upon the Borough's most recent application.

<u>Roof Project:</u> The Borough Hall roof reconstruction project is temporarily on hold due to this evening's storm event and anticipated moderate tidal flooding tomorrow. The contractor mobilized most of the materials to the roof of the building and moved most heavy equipment out of the parking lot. I anticipate the re-mobilization to begin on Friday.

Storm Update: Due to the anticipated flooding tomorrow, Borough Hall will not be open to the public per the decision by the Mayor and Avalon's OEM Director. There will be no access to the building on Thursday, with normal operations resuming Friday. Ken Koches from Middlesex Water Company represents all stormwater, wastewater, and well pump operations were tested and fully operational in advance of the tidal flooding that is anticipated. NJDEP will be on our beaches, among others, Thursday and Friday to do post storm assessments.

Emergency Communications: As my role as Public Information Officer, I will be involved in two separate meetings before the end of the month. One will be to have additional training on expanded services offered by our Code Red emergency alert platform that will permit the Borough to utilize text messages when appropriate for emergencies, and to create zones where an emergent condition exists in one part of town only. For instance, earlier this year we had a tornado warning just north of Avalon. It takes about seven minutes to execute and receive a phone call due to various security protocols. The text can through almost instantly. And, our partners at the New Jersey Coastal Coalition have developed a new phone app that will allow the public to zoom in to neighborhoods for potential flood impacts. I expect to roll both of these programs out during first quarter, 2021.
