Reports and Recommendations by Mayor and Officials: Reports of Officials:

Scott Wahl read the following report:

Electronic Delivery of Meetings: At the request of Council President McCorristin, I have begun an investigation into the options for a live streaming component of our Council meetings. It is clear that there are two options to further explore in regards to this service. Both options would include the live, real-time audio and video streaming of Borough Council meetings with the entire video file being uploaded for later review on the municipal website. One option is to have a "pay per meeting" arrangement with a video company who sets up the camera, provides the service, and uploads it to the municipal website after the meeting. The second option is to expand the media capabilities in the Council meeting room whereas the Borough can simply hit two buttons to start and stop the live streaming, with the video automatically uploaded for later viewing. If there is a preferred option, I will obtain more quotes for Council's review.

Police Accreditation: There are many benefits for having a municipal police department accredited, and then re-accredited. The JIF and the MEL both recognize this, and this week announced that reimbursements and grants are being made to the local police departments who go through this process, or are re-accredited. Avalon qualifies and will receive \$3,000 of this funding.

COVID-19: I have communicated with County Health Department Director Kevin Thomas about some frequently asked questions and issues getting appointments through the state for the vaccine. In lieu of waiting for a document to arrive, and after speaking with our staff, I have compiled our own list of information to help Avalon residents sort out fact from fiction. I believe it is interesting to note that through the State program, there have been 6,275 vaccinations provided at Avalon Community Hall, while the county wide total is 16,659 as of this morning. Individuals are clearly exploring options outside of the State program to get vaccinated. Thanked Sue Keen for all of her helping our residents and property owners with any questions they may have.

Beach Patrol: After an extensive interview process, Mayor Pagliughi and Chief Christopher have appointed longtime Avalon Beach Patrol Lieutenant Matt Wolf to the position of Chief of the Beach Patrol, and longtime Lieutenant Ryan Black to Captain of the Avalon Beach Patrol. Matt and Ryan have a combined 37 years of experience with the Beach Patrol, both are educators, and both hold Master's Degrees. Their appointments follow the retirement of Murray Wolf, who started working on the Avalon beaches in 1955 and has served as Captain of the Beach Patrol since 1967. Both Matt and Ryan are working on policies and recruitment of guards and taggers for the upcoming beach season.

Councilwoman Hudanich thanked Scott Wahl and Sue Keen for working to inform the public about the COVID-19 vaccination process while noting the ultimate decision-making is done by the Cape May County Department of Health. She announced the availability of registering online for a vaccination; however, noted residents outside of Cape May County will not be eligible to be vaccinated at Avalon Community Hall. She commended the Cape May County Department of Health for their hard work.

Councilwoman Juzaitis added the Borough of Avalon's only involvement is providing the building for the

health officials to administer the vaccinations.
Council President McCorristin requested that further information and quotes be presented to Borough Council regarding the two options for a live streaming component for the Council meetings.
Councilwoman Hudanich also requested that the information include if the component will be unilateral or interactive.
