beginning to return to normal. Inside programs are anticipated in September. The summer mailer will be sent out soon to every Avalon property address and it includes over 100 events that will be held throughout July and August.

Motion was made by Trustee Petrucci, seconded by Secretary Schwartz to approve the hiring of three seasonal Library Monitors at a rate of \$20/hour for 19 hours a week, effective June 19, 2021 through August 27, 2021. Motion passed unanimously by those present.

Motion was made by Trustee Hoy, seconded by Treasurer Thatcher to approve the hiring of one seasonal Museum Assistant at a rate of \$17/hour for 19 hours a week, effective June 19, 2021 through September 4, 2021. Motion passed unanimously by those present.

Motion made by Trustee Petrucci, seconded by Trustee Hoy to suspend the accumulation and collection of library fines and fees through December 31, 2021 except in the case of items with a value of \$75.00 or greater. Motion passed unanimously by those present.

Seven Mile Publishing Update:

Patty Davis' Board Report was presented using a slideshow presentation. In July they will be highlighting the Authors in Conversation program, outdoor events, History Center, scavenger hunt and StoryWalk® with a link to the calendar to the other events. Social Media for the month of May reached over 25,000. Hoopla is the featured resource of the summer. There will be a press release for the Authors in Conversation and a dedicated email that will be sent the Monday of each Author's event.
