ORDINANCE NO. 845-2022

AN ORDINANCE AMENDING AND SUPPLEMENTING VARIOUS SECTIONS OF CHAPTER 2 OF THE AVALON BOROUGH CODE PERTAINING TO THE REORGANIZATION OF DEPARTMENTS GENERALLY AND TO THE PLAN OF REORGANIZATION FOR THE DIVISION OF RESCUE SQUAD-EMERGENCY MEDICAL SERVICES AND THE REORGANIZATION OF THE DIVISION OF RECREATION

This Ordinance amends several sections Chapter 2 of the Borough Code, as herein described:

Section 1: Amends the following sections of the Borough Code:

- § 2-4.2 (Organization of Departments) is amended to provide as to how recommendation for reorganizations of Borough Departments or Divisions is implemented and provided that same may be approved or rejected by Borough Council by Resolution and abolishes the requirement that approval or rejections be granted /rejected by ordinance.
- § 2-6.6 (Divisions within the Department of Administration) is amended to approve a Plan of Reorganization and to define the functions of the Division, to create two (2) new job classifications (Administrative Coordinator Recreation and Operations Coordinator Recreation) and to define the qualifications and duties of individuals holding such positions.
- § 2-6.6 is further amended to codify the Division of General Code Enforcement and to codify the duties and responsibilities of that Division within the Department of Administration
- § 2-64 (Division of Rescue Squad Emergency Medical Services) is amended to approve a Plan of Reorganization which names a Chief of Emergency Medical Services who henceforth will be the Division Head. The Chief will perform those duties and responsibilities previously assigned to the Coordinator. The position of Coordinator is maintained but the position will remain vacant. The Division remains under the jurisdiction of the Director / Deputy Director of the Department of Public Safety.
- The above Plans of Reorganization for both Divisions is scheduled to become effective July 1, 2022.

Section 2 & 3: Provides that all inconsistent ordinances are repealed and that the provisions are severable.

Section 4: The Ordinance will take effect immediately.

This Ordinance was introduced and passed on first reading on June 8, 2022 and will be further considered for second reading, public hearing and final adoption on June 22, 2022 at the Municipal Building, 3100 Dune Drive, Avalon, NJ 08202 at 4:15 p.m.
