Ordinance No. 854-2023:

AN ORDINANCE REQUIRING THAT ALL BUSINESSES AND OWNERS OF RENTAL UNITS CARRY LIABILTY INSURANCE IN CERTAIN DESIGNATED AMOUNTS AND FILE PROOF OF SAME WITH THE BOROUGH PURSUANT TO P.L. 2022. C.92 AND FURTHER REQUIRING THAT ALL BUSINESS LOCATED WITHIN OR TRANSACTING BUSINESS WITHIN THE BOROUGH OF AVALON REGISTER WITH THE BOROUGH ANNUALLY AND PROVIDING PENALTIES FOR THE VIOLATION HEREOF

Council President Wierman opened the meeting for public hearing on Ordinance No. 854-2023 and asked if there were any questions or comments.

Martha Wright, 632 7<sup>th</sup> Street, inquired if the amounts of required coverage were set by the State or the Borough.

<u>Council President Wierman</u> responded the State set the coverage requirements, and the Borough is memorializing those requirements by Ordinance.

<u>Martha Wright</u> questioned if the Borough of Avalon drafted specific portions of the Ordinance, namely the sections addressing licensing and inspection, and asked for clarification on the section addressing "inspections outside of scheduled inspections".

<u>James Waldron</u> explained there are certain inspections carried out by the Borough in accordance with various chapters of the Borough Code. Those inspections will continue to be carried out without any additional fees. If a violation is detected, corrective action will be required on the part of the offending party. If there is a zoning application that results in a variance or site plan, the property is subject to periodic review and inspections at periodic intervals for up to 18 months.

Paul Short added complaints will trigger unscheduled inspections, as well.

<u>Martha Wright</u> asked if the Certificates of Insurance are required to name the Borough of Avalon as an additional insured party.

<u>James Waldron</u> indicated the insurance being required under this Ordinance does not name any additional insured, as the requirement is to hold coverage only and provide proof of same. This Ordinance references other existing sections within Borough Code requiring the naming of the Borough of Avalon as an additional insured party; those sections having been adopted by Borough Council prior to the legislature's recent actions. In those instances, the Borough of Avalon's insurance requirements are higher than the states minimum requirements, and the Borough's requirements would prevail over the state minimum limitations.

<u>Councilman McCorristin</u> clarified there are no Borough requirements in excess of the state requirements for rental licenses at this time.
