both celebrated fifteen years with the library. The Trustees were briefed on local First Amendment Audits, guidelines for staff and Code of Conduct review. Bay Atlantic Symphony has drafted a proposal for a three-part outdoor concert series at Surfside Park for Summer 2023. Happy Noon Year welcomed over 175 children and their families on December 31. Community Report 2022 highlighted the welcoming of 781 new members and 161,606 items borrowed in person and online, the highest in past five years. Live special events and programs were attended by 8,782 participants. Goals for 2023 are to better communicate how patrons can utilize the library whether in person or online. Business services are popular with public usage of PCs, Wi-Fi and printing.

Patty Davis began with social media statistics for December with a reach of 17,913. The monthly e-newsletter released on the first Wednesday, was below the desired clicks of 5%. Since the new redesign, the clicks are now above average at 8%. Patrons are looking at programs and new book titles. They will continue monitoring and adjust as needed. Features for January include Unicorn Space, Hoopla and Library by Mail.
