A Meeting of the Borough Council of the Borough of Avalon was held on Wednesday, April 24, 2024, at 4:00 p.m. in the Meeting Room, 3100 Dune Drive, Avalon, New Jersey.

Council President McDermott read the Open Public Meetings Act Announcement.

Notice of this Council Meeting was included the annual Schedule of Meetings dated July 12, 2023. It was given to the news media and posted on the Official Bulletin Board as required by law.

Council President McDermott read the following statement:

"For the convenience of the public, the Borough is offering the option of public comment via remote access as described herein. Public who participates remotely will be muted during the Council Meeting except at the public comment portion of the meeting. Any person attempting to disrupt the remote broadcast of a meeting may be denied access at the discretion of the person administering the meeting. Public is reminded of a five-minute limit per comment. In the event remote access is unavailable due to a technology malfunction, or other reason beyond the Borough's control, the Borough will not pause or stop the live meeting. Borough Council Meetings are held in person with no capacity limits on attendance at a meeting. The best way to ensure an individual's ability to publicly comment is to attend in person so that comments may be made in the event of a technology malfunction. The Borough reserves the right to discontinue offering public comment via remote access at its discretion for any future meeting."

Discussion regarding Resolution authorizing a public auction of abandoned or unclaimed property

<u>Chief Christopher</u> noted the Avalon Police Department intakes various items of property throughout the year. When that property is obtained by the Police Department, the Detectives employ various investigative methods to locate the rightful owners of the property so that it can be returned. All remaining property not reunited with the owner is held for a minimum of six months, and then is readied for an annual auction. A list of items to be auctioned this year has been provided to Council.

Council agreed to proceed with a Resolution to be considered at today's meeting.

<u>Discussion regarding Resolution authorizing the relocation and installation of stormwater infrastructure and authorizing payment at Block 7.07, Lot 138 (576 7th Street) and Block 7.08, Lot 140.01 (606 7th Street).</u>

Danielle Nollett announced this item has been deferred until further notice.

<u>Discussion regarding Resolution authorizing Change Order No. 1 in connection with Contract M-130, 22nd Street Water Main Replacement.</u>

<u>Thomas Thornton</u> explained this Change Order consists of three items; the first of which was required to extend the water main replacement to include the replacement of the cast iron main on Harbor Avenue. The second item included additional valves, pipes, and fittings required and requested by Middlesex Water Company to improve the ability to operate the system in that area. The final item was to replace an old lateral with PVC.

Council agreed to proceed with a Resolution to be prepared for the May 8, 2024 Council Meeting.

<u>Discussion regarding Resolution authorizing construction phase engineering services in connection with 2024 Backpassing Project.</u>

Thomas Thornton noted this proposal is to provide construction phase engineering services required for the upcoming beach renourishment project, which will include the typical inspection services in addition to monitoring services required by the state and federal agencies for such a project. The permit held by the Borough of Avalon for these types of projects has very strict requirements for the monitoring of piping plovers, which includes required monitoring for four days prior to the start of the project as well as daily monitoring during the project. This year, there is an added requirement to monitor for red knots during those observations. It is proposed to hire a subcontractor with a certified biologist on staff to meet the requirements of the agencies to perform those observations.

Council agreed to proceed with a Resolution to be considered at today's meeting.

<u>Discussion regarding Resolution declaring an emergency and authorizing the purchase of materials in addition to an award of contract to make certain repairs at the Avalon Sport Fishing Center.</u>

James Waldron reported Code Enforcement conducted an investigation of the Avalon Sport Fishing Center on April 9, at which point it was determined that the public pier providing ingress and egress to the Miss Avalon and Avalon Lady was substantially deteriorated and in imminent danger of collapse. At that time, the pier was condemned, hence denying public access. The Engineer conducted an investigation within 24 hours, arriving at the same conclusion as Code Enforcement. These circumstances give rise to the award of a contract without competitive bidding to repair or replace the pier. The Qualified Purchasing Agent and Chief Financial Officer both concur the emergency elements are present to justify the emergency award of a contract under these circumstances. The Engineer has provided a certification as to the estimate of the cost to replace or repair the pier. The Resolution presented to Council today authorizes a contract award at either the Engineer's estimate or the sum of \$100,000.00, whichever is less.

Council agreed to proceed with a Resolution to be considered at today's meeting.

Discussion regarding bids received for Contract No. M-137, 2024 Beach Replenishment.

Thomas Thornton indicated the bids received for this project were submitted at a wide range in cost. The apparent lowest bidder was contacted to discuss the demands of the contract as well as the project scope. During that conversation, the contractor expressed their full commitment to conducting the work properly with the appropriate equipment, and provided a list of references and experience. Those references were confirmed with positive feedback; therefore, it is recommended to award the contract to the lowest bidder.

Council agreed to proceed with a Resolution to be considered at today's meeting.

<u>Discussion regarding request to reduce the size of an easement retained by the Borough of Avalon pursuant to Ordinance 34-80 pertaining to 576 7th Street</u>
