Public Comments:

<u>John Rogers, 695 21st Street,</u> made note of recent construction in his neighborhood which has exacerbated a flooding issue, making many yards uninhabitable and raising health and safety concerns, in additions to Borough violations as it pertains to standing water on private property. He expressed understanding that the property was built to code with regard to grading; however, requested help from the Borough of Avalon to find productive solutions for this problem.

<u>Joseph Osifchok, 698 Sunrise Drive</u>, noted the severity of the flooding in this area after a recent rain event and indicated measures he had recently taken to try to alleviate flooding in his yard; however, the problem persists. He made mention of impervious coverage in the area, and identified some potential solutions for Council's consideration. He echoed the health and safety concerns raised by Mr. Rogers and also requested the Borough help the neighbors solve this problem.

<u>Kristin Camp, 675 21st Street,</u> reiterated the concerns of flooding in the neighborhood, and requested guidance for measures that can be taken by individual property owners, as well as the Borough of Avalon as a whole.

<u>Heidi Ramer, 695 21st Street,</u> stressed the health and safety concerns raised by standing water caused by flooding. She asked for a community solution to this issue.
